

## **SUMMARY ANNUAL REPORT**

### **For Rakuten Usa, Inc. Welfare Benefits Plan**

This is a summary of the annual report of the Rakuten Usa, Inc. Welfare Benefits Plan, EIN 94-3377047, Plan No. 501, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Rakuten Usa, Inc. - Rakuten Americas Regional Headquarters, Inc. has committed itself to pay certain self-insured Medical, Dental, and Vision claims incurred under the terms of the plan.

### **Insurance Information**

The plan has contracts with Hartford Life And Accident, Delaware American Life Insurance Company, Pre-paid Legal Services Inc dba LegalShield, Modern Health Arizona P.L.L.C., Cigna Health And Life Insurance Company, and Kaiser Foundation Health Plan, Inc. to pay Medical, Dental, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, International Business Travel, Legal, Critical Illness, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$4,569,381.
